6. COUNTRY OF EXPORTATION	This is the country from which the items are shipping (e.g. Canada).

8. DESCRIPTION AND QUANTITY OF MERCHANDISE	State the description of the item (e.g. diesel fuel injector) and the quantity, plus the following statement (using the appropriate item description): <i>Used injectors of U.S. origin being returned for warranty consideration.</i>
9. VALUE	Value of item(s) in U.S. dollars. Important Note: This total must be less than \$2000 to use CBP Form 7523.
